1. To review of the structure of the syllabus
2. To discuss and identify the courses which provide employability
3. To discuss on introducing Value added course
4. To discuss on introducing Certificate courses with MOU from reputed organisation
5. Review the list of paper setters

The meeting started with Dr. Seema Ghosh welcoming the members of BOS.

Proposals at the Meeting

There was a proposal to identify the courses which provide employability to the students. There was also a proposal to make a list of value added courses of 30 hours in economics to be offered with external resource persons. It was also proposed to explore the possibility to identify and list some certificate courses in Economics with MOU from reputed organization.

Resolutions of the Meeting

1. Prof. B. Sudhakar Reddy expressed that the core and elective courses in economics offered in BA program cannot be identified as employable courses. Though the skill enhancement courses like Basics of Quantitative methods for Economist I and II and Basics of Computers I and II are the employable courses. The scope of employability will happen only after the students complete the program. It was resolved that the core and elective courses offered in economics in BA program cannot be categorized as employable courses and Skill enhancement courses can be categorized as employable courses.
2. The Board suggested Personal Financial Planning, Wealth Management, Introduction to Econometrics, Environmental Economics, Practical application of E-views software for data analysis can be offered as value added courses from department of economics. It was resolved that the department will explore the possibility for introducing the suggested value added courses in the next academic year.
3. The Board suggested that the department can examine the association with The Indian Econometric Society and Insurance Regulatory and Development Authority for introducing certificate courses. It was resolved that the department will explore the possibility of tie ups with the suggested organization for the certificate courses.
4. The Board added a name in the list of examiners for paper setting and evaluation.

1. To approve of syllabus of 5th and 6th semester of Economics subject (CBCS) w.e.f. 2019-2020 in BA undergraduate course.
2. To approval the syllabus of Skill Enhancement course –Paper III- 5th Semester Paper IV- 6th Semester.
3. To approve the question paper pattern and marks distribution for semester end examination and CIAI and CIA II examinations.
4. To approvethe panel of examiners.

The meeting started with Dr. Seema Ghosh welcoming the members of BOS.

Proposals at the Meeting:

1. There was a proposal to include another theory of economic development in Unit IV and also to replace Myrdal theory (Unit V) with the choice of techniques as a strategy of Economic development in Development economics course (DSC) in semester V. There was a proposal to include Venture capital topic instead of functions of NSE and BSE in Unit V of Financial Economics course (DSE) in semester V. The Board accepted the suggestion.
2. There was a proposal to include pre and post trends of national income in India in Unit I, industrial policy of 1956 in Unit II and elaborate the topics of liberalization, privatization and globalization in Unit IV of Indian Economy course (DSC) in semester VI. There was a proposal to delete Theorem of factor price equalization in Unit I, include Hypothesis of Secular deterioration of terms of Trade in Unit II, distinction between tariff and non-tariff barriers in Unit III and to shift concept of devaluation of currency from Unit V to Unit IV in International Economics course (DSE) in semester VI. The Board accepted the suggestion.

Resolutions of the Meeting:

1. The Board approved the syllabus of Paper V- Development Economics (DSC) and Paper VA – Economics of Education (DSE), Paper VB- Demography (DSE) and Paper VC - Financial Economics (DSE) of 5th semester for Economics subject (CBCS) w.e.f 2019-20.
2. The Board approves the syllabus of Paper VI – Indian Economy (DSC) and Paper VI A- International Economics (DSE), Paper VIB- Economics of Insurance (DSE) and Paper VIC – Industrial Economics (DSE) of 6th semester for Economics Subject (CBCS) w.e.f. 2019-20.
3. The Board approved the syllabus of SEC Paper III (Basics of Computers I – Word and Power point) and SEC Paper IV (Basics of Computers II – MS Excel) for 5th and 6th semester for Economics Subject (CBCS) w.e.f. 2019-20
4. The Board approved the question paper pattern and marks distribution for semester end examination and CIA I and CIA II examination of 5th and 6th semesters.
5. The Board approved the list of examiners for paper setting and evaluation.

Skill to recognize important issues involved in the field of economic development at the community, state, regional, national or international level.


Skill to recognize and analyze the issues related to Education sector in India.


Skill to have a comprehensive understanding and knowledge about the past, present and future population scenario of India, and the various demographic events and processes that shape the population size and structure.

Proposals at the Meeting:

1. Title of "Public Economics" was approved as Paper IV for 4th semester for Economics Subject (CBCS) in BA undergraduate course in the previous BOS meeting. There was a proposal to introduce Banking along with Public Economics in Paper IV of 4th semester. The proposal was to divide the syllabus with three units on Public Finance and two units on Banking. The Industry Expert Mrs. Kalapagam also reiterated the importance of knowledge of Banking for the students. The Board accepted the suggestion.
2. Title of Skill Enhancement Course (SEC) was approved in the previous BOS meeting. The Skill Enhancement Course Paper I (Basics of Computers I) and Paper II (Basics of Computers II) of 3rd and 4th semester was proposed to be re-arranged with SEC Paper III (Basics of Quantitative Methods for Economists I) and Paper IV (Basics of Quantitative Methods for Economists II) of 5th and 6th semester. The proposal was made in order to introduce Quantitative Methods for Economists in the 2nd year of the BA program itself. The Board accepted the suggestion.
3. Title of Generic Elective (GE) Paper I (Telangana Economy) and GE Paper II (Economics of Environment) was approved in the previous BOS meeting. There was a suggestion from the subject expert Dr. Sirisha to offer "Basics of Economics" as GE Paper I instead of "Telangana Economy". Important aspects of Telangana Economy could be included in Indian Economy Paper in semester V. The Chairman, BOS, Department of Economics, OU, Prof. J. Narasimha Rao suggested to consult Prof Prabha Pant, Retd. Professor, Department of Economics, OU to make changes in the syllabus of GE Paper II (Economics of Environment). The Board accepted the suggestion.

Resolutions of the Meeting:

1. The Board resolved and approved to modify the Title of Paper IV of Economics subject from "Public Economics" to "Public Finance and Banking" to include two units on Banking in the syllabus.
2. The Board approved the syllabus of Paper III (Macro Economics), 3rd semester and Paper IV (Public Finance and Banking) 4th semester for Economics Subject (CBCS) w.e.f.2018-19.
3. The Board resolved and approved for the re-arrangement of the SEC papers. The syllabus of SEC Paper I (Basics of Quantitative Methods for Economist I) and Paper II (Basics of Quantitative Methods for Economists II) for 3rd and 4th semester for Economics Subject (CBCS) w.e.f.2018-19 is approved.
4. The Board resolved to offer "Basics of Economics" as GE Paper I instead of "Telangana Economy" and approved its syllabus after discussion. The syllabus of GE Paper II "Economics of Environment" is also approved after incorporating necessary suggestions made by Prof Prabha Pant.


