At the outset, Prof. Y.Ashok, Principal of the College and Chairman of the Standing Committee welcomed all the members to the meeting. He informed them of the need to consider various aspects of conducting examinations in view of the ongoing pandemic.

<u>I - (a) Conduct of final semester exams for UG/PG - Regular :</u>

Osmania University, through its Order No.659/M/Acad-1/2020 dated 31.08.2020 has approved the conduct of final semester examinations of all UG/PG students for the academic year 2019-2020.

In view of this order mentioned above, the college proposes to conduct exams for final semester UG & PG students for the 2019-2020 passing out batch. It is proposed to conduct the PG regular exams between 10th and 23rd September 2020 and UG regular exams between 14th and 23rd September 2020. A tentative schedule of examinations has already been communicated to the students.

The Principal informed the members that no representations have been made by the students regarding the conduct of exams and schedule of exams.

Resolution : It is resolved to conduct the final semester pending Regular exams (UG & PG) for the 2019-20 batch. The PG exams will commence from 10th September and the UG exams from 14thSeptember 2020.

I - (b) Backlog exams for final semester students :

The Offg. Controller of Examinations gave details about the Backlog exams that need to be conducted for the 2019-20 passing out batch. The members were also informed about the Backlog exams required for final semester students of 2017-18 and 2018-19 batches. The Chairman, Academic Council, sought the Standing Committee's approval for conducting Backlog exams for final semester students of 2017-'18 batches.

<u>Resolution</u>: It is resolved to conduct Backlog exams for the final semester students of 2019-20, 2018-19 and 2017-18 batches.

I - (c) Promotion of Intermediate semester students - UG & PG :

The Osmania University Order No.659/M/Acad-1/2020 dated 31.08.2020 provides guidelines for promotion of UG & PG students of intermediate semesters.

In accordance with these guidelines, the college proposes to promote UG & PG students of Intermediate Semesters for the academic session 2019-'20. However, these students will be required to take the pending exams at a later date.

<u>Resolution</u>: It is resolved to promote all students of the Intermediate Semesters (UG & PG) for the academic year 2019-'20, As a one-time exception, the rule of detention will not apply to intermediate semesters students of 2019-'20. 'However, all pending exams (Regular & Backlogs), for the UG I & II years and PG I year will be conducted subsequently when the situation normalizes. Students are required to clear all the exams to be eligible for award of degree.

I - (d) Pattern and Duration of the examinations :

The members discussed in detail the proposed pattern and duration of exams to be conducted for the final semester students. The members advised the college to make minimum changes in the Question paper pattern and total marks and to ensure that the quality of the question papers is not compromised. Also, changemay be limited to the time allotted for each exam.

<u>Resolution</u>: The question paper pattern and duration of exams are approved as follows :

Duration of the exam : 2 hours Maximum marks : 70 marks

Paper Pattern for courses with four units :

Section A : Answer any 5 out of 10 questions (5 x 6 = 30) Section B : Answer any 2 out of 04 questions (2 x 20 = 40)

Paper Pattern for courses with five units :

Section A : Answer any 5 out of 10 questions (5 \times 6 = 30) Section B : Answer any 2 out of 05 questions (2 \times 20 = 40)

I - (c) Any other points with the permission of the chair :

In addition to the above the following points have also been approved.

- 1. <u>Special exams</u> will be conducted, at a later date, for students who are unable to write the exams now due to medical and/or other reasons.
- 2. <u>Moderation of question papers</u> will be carried out by the Chairpersons, Boards of Studies of various courses or by a competent faculty member in the presence of the Chairperson, Board of studies.

Suggestions :

- 1. All measures taken by the college to prevent the spread of COVID may be listed and communicated to students and parents through the college website and other means.
- 2. An advisory may be issued to the students with details of DOs and DON'Ts to be followed from the time of entry in the college to the time of exit from the college.

The Action Taken Report was presented by Prof. Y. Ashok, Chairperson, Academic Council, BVC.

The following suggestions were made by the members:

a) The number of teachers engaged in research should increase.

b) Regarding poor results in Chemistry, the cause should be identified and resolved.

An assurance was given by the Principal for personally looking into the matter and ensuring improvement in results of Chemistry.

Resolution: The Minutes of the 6th Academic Council Meeting are approved.

Consideration and approval of the decisions of the Board of Studies of all the departments:

The Boards of Studies meetings of all departments were conducted between 29th May 2020 and 23rd June 2020. The decisions of the Boards of Studies of all departments were presented by the Heads of the Departments.

The following suggestions were made by the members:

1. The faculty members should prepare for blended learning with some topics identified for selflearning.

2. The College should devise guidelines with respect to teaching, learning and evaluation, to be followed uniformly by all departments.

3. Conduct a survey among students to assess the preparedness for online education.

4. Avoid conducting any form of online assessment for the time being.

5. Commencement of classes should be done after declaration of result.

Resolution: All decisions of the Boards of Studies of all departments are recommended for approval by the Governing Body.

Consideration and approval of College almanac 2020-21 : (c)

The college almanac for 2020-'21 was presented. The Principal informed the members that the almanac was tentative due to the uncertainity on account of the COVID-19 Pandemic. The members recommended

that the decisions regarding the college almanac may be taken as and when required in view of the prevailing situation.

Resolution: The Principal is authorised to take decisions on the basis of State Council/ UGC guidelines and the prevailing situation.

i) B.Sc (Microbiology, Nutrition & Dietetics, Chemistry) :

The proposal for the Programme was discussed in detail. The members were informed that the infrastructural requirements have been assessed and that faculty for Nutrition will be appointed.

The ceiling strength for the Programme is 50 students.

The Department of Biochemistry will be the nodal department for the Programme.

Resolution: The Programme is approved subject to infrastructural and faculty requirements being met.

ii) B.Sc (Honours) Data Science :

The proposal for the Programme was discussed at length. The members were informed about the course fee, student intake, and credits for the Programme.

The tution fee for the Programme is Rs 70,000/- per annum and the ceiling strength for the Programme is 50 students.

The Board of Studies had approved the Programme with 150 credits. However, taking the advice of the Academic Council for a higher number of credits, the number of credits has been increased to 156 credits.

The following suggestions were made by the members:

- 1. A difference of 20 credits is advisable between BSc Regular and BSc Honours programmes. So the number of credits for the Programme may be increased.
- 2. The Programme must include a Project and an Internship. A special effort may be made to ensure that all students secure an internship.
- 3. External examiners for the Data Science programme may be taken from engineering colleges, instead of Industry as proposed by the Board of Studies.
- 4. The college is advised to explore the possibility of an Integrated M.Sc (Data Science) Programme, with exit option, in the future.

Suggestion: It is recommended to have one nodal department for the Programme.

Resolution: The Programme is approved subject to providing necessary infrastructure and appointing required faculty.

(e) <u>Any other points with the permission of the Chairman:</u>

There were no other points to be discussed.

The Meeting ended with a vote of thanks by the Member Secretary.

National Integration Quota - This may be implemented in UG courses as per State Council / OU guidelines.

Programme Structure - An autonomous college may deviate from the university syllabus to ii) the extent of 20% within the basic programme structure followed by the parent university.

Certificate Courses - These may be courses that offer hands on experience instead of iii) theory alone. The Academic Council resolved to recommend to all departments to offer at least one Certificate Course

(b) <u>Approval of the minutes of the Standing Committee Meeting:</u>

Minutes of the Standing Committee Meeting held on 17th July, 2019 were unanimously approved.

The Action Taken Report (ATR) was presented by the Principal.

Brief on College Activities - : The Principal gave a power point presentation on the College (C) activities held up till December 2019 :.

- (ii) The fact that the Dept. of Management Studies of the college has submitted a proposal to Osmania University for recognition as a Centre for conducting research leading to Ph.D degree may be recorded.

The details of syllabus and programme structure for the entire period of study, along with the recommendations of the respective Boards of Studies, may be presented to the Academic Council / Standing Committee of the Academic Council for consideration and approval before commencement of the programmes.

The members made the following suggestions in this context:

- *(i) A Programme should be named in accordance with the nomenclature approved by UGC.*
- (ii) An 'Honours' degree programme should be distinctive and reflect higher value than the regular degree programme in terms of the number of years of study, courses, curriculum, credits, project, research component etc.
- (iii) The college may offer the Honours programme as a four year degree programme with an exit option at the end of three years. The fourth year is devoted to internship / research project, as recommended in the National Education Policy 2019.

Suggestion :

Head, Department of Biochemistry, suggested that Nutrition & Dietetics course may be considered as the workload of Department of Biochemistry, as is the practice in the parent university (Osmania University).

- (f) Examination related matters:
 - *i)* Conduct of backlog examinations during odd semester:

Resolutions:

- (i) Backlog exams in Odd Semesters may be conducted for odd semester backlogs of regular students from the next academic year (2020-21).
- (ii) Conduct special examination in the paper(s) concerned for any student, if he/she missed it (them) in the regular schedule of examinations while participating in Sports / Games / NCC / NSS / co-curricular activities at National / International
 - level, provided that

The student concerned is representing the College in the event, made prior representation and obtained the approval of the Principal.

ii) Conversion factor for CGPA:

Resolution:

i) Instead of converting the CGPA into percentage of marks, a letter may be issued separately, on request made by a student and payment of a nominal fee, mentioning

the percentage of marks scored by the student. Such a letter should be signed jointly by the Principal and the Controller of Examination.

(g) Briefing on NAAC Re-accreditation :

The principal informed the members that the process for NAAC Re-accreditation will start in June 2020 with the submission of IIQA in July 2020. The process of Re-Accreditation is expected to be completed by December 2020.

(h) Any other points with the permission of the Chairman:

(i) The Principal sought approval of the council for introduction of one online course as a mandatory course for PG students and students of B.Com (HBA) and BCA.

Resolution:

The proposal is approved, provided that the respective Boards of Studies have recommended.

(ii) The student representative gave the following suggestions :

(a) Convocation may be conducted for passing out students.

(b) Students may be permitted more time for their project work.

Resolution :

- (a) The College being autonomous should conduct its own degree awarding ceremony for the outgoing students every year in consultation with the CoE of Osmania University.
- (b) The suggestion regarding more time for project work will be discussed in a meeting of the Heads of the Departments.

As there were no other points for discussion the meeting ended at 2.45 pm. Chairman of Academic Council Prof. Y Ashok thanked all the members for sparing their valuable time and also giving good suggestions.

In view of these facts, the Principal sought the members' opinion on the possibility of implementing the revised syllabus with effect from 2019-20. The Principal also informed the members that the college has not received any official communication in this matter from the Telangana State Council for Higher Education or the University.

All the Heads of the Departments then informed the committee about the variation in the syllabus approved by their Boards of Studies and the revised CBCS syllabus. It was also noted that the revised syllabi of Physics, BCA, BBA, Economics, Mass Communication, Political Science, Hindi, Sanskrit, Telugu and French have not yet been uploaded on the Osmania University website.

<u>**Resolution**</u>: It was resolved to implement the revised CBCS structure and syllabi, mandatorily, with effect from 2020-21 academic session. The following reasons are the basis for this resolution:-

- a. The almanac of the 2019-20 session has already been approved by the Academic Council and Governing Body of the College and has also been communicated to the students.
- b. The college has completed one month of the current semester. Any change now in the syllabus /Programme structure will adversely affect the teaching and examination schedule
- c. The syllabi, as approved by the respective boards of studies, have been intimated to the students at
- the beginning of the session.
- d. The first internal test (CIA 1) of the college is scheduled from 21/8/19 to 23/8/2019.
- e. The academic departments require time to make necessary modifications in the syllabi to suit the specific requirements of the overall programme structure in the college and also to meet the UGC regulations for autonomous colleges.

Suggestions:-

- Minutes of the meetings of the Academic Council and Governing Body of the College may be communicated to the Registrar and Dean, College Development Council, Osmania University.
- All Heads of the Departments are hereby requested to take necessary action for the implementation of the revised CBCS syllabus and structure from 2020- 21 academic session.

- b) The college is ranked below 200 (151 to 200) in the country by National Institutional Ranking Framework for the year 2019. This is the second consecutive year with same ranking for the college.
- c) Proposal Grace. marks for Sports students vide Osmania University Order No.958/M/Acad./2015 dated 16.06.2018

Resolution :

Order No.958/M/Acad./2015 dated 16.06.2018 of Osmania University regarding grace marks for sports students will be adopted as it is from the batch of students who have appeared for Semester End Examinations in March/April 2019. Minutes of the 3rd Academic Council Meeting held on 18.4.201 7 and Minutes of the Standing Committee Meeting held on 24th July 2017 are unanimously approved.

The Principal presented the Action Taken Report (ATR) to the members. The following suggestion was made on the basis of the ATR:

i) Professional Service Centreto be made a part of the Career Guidance and Placement Cell (CGPC).

b)Brief on College Activities: The Principal gave a power point presentation on theCollege activities held during 2017-18.

The members expressed appreciation for the commendable achievements made by the college.

The Council specially congratulated the Management, Principal and all Staff members for being one among the three colleges in Telangana within top 200 ranks in the NIRF ranking.

(c) Consideration and approval of the decisions of the Boards of Studies :

The Principal informed the Academic Council that Boards of Studies meetings of all the departments, except Department of Political Science, were conducted between 22nd March 2018 and 5th April 2018.

The Board of Studies meeting for Political Science could not be conducted as the nomination from the University has not been finalized.

Reconstitution of all Boards of Studies is required as their threeyear term is completed. Members suggested to include a student in all the Boards of Studies of the concerned department.

Suggestion : Syllabi of all courses must be uploaded on the College website.

(d) College Almanac :

Dr. Jyothi Nayar, Academic Coordinator, presented the College Almanac to the Council.

(g) Briefing NAAC Reaccreditation :

The Principal briefed the Academic Council on preparation for NAAC Reaccreditation. He informed the Council that the SSR will be submitted in the next window which is likely to open in May/June. The preparation started in September 2017by formation of Committees for the seven Criteria. Each Criteria Committee is coordinated by the Head of the Department. In addition, a Committee is formed for Screening the content of the Criteria reports and another Committee for document verification and uploading. A Committee is formed for making the Self Study Report with the content finalized by an Expert Committee under the guidance Prof. P.S.N Reddy.

b) <u>Brief on College Activities</u>: The Principal gave a power point presentation on the college activities held during 2016-17. The members of the Academic Council expressed appreciation for the commendable achievements made by the college. The council made the following suggestions:

- To devise a formal method of communicating appreciation of Academic Council to the achievers.
- ii) Minimum & maximum salary offered during college placements may be highlighted in the placement record

(c) <u>Consideration of proposals/recommendations of Boards of Studies</u>: Principal informed the Council that Boards of Studies meetings of all the departments were conducted between 20 March 2017 and 12 April 2017. The faculty in-charges presented the templates of CBCS course structure and credits.

All proposals and recommendations made in the Boards of Studies meetings and course wise templates are approved with the suggestion that the BCA course may implement the five day teaching and one day other academic activity schedule with effect from 2017-18.

(d) Consideration of change of subject combination in BA :

The College is now offering B A course with three optional subjects - Modern Language (English Literature), Political Science & Mass Communication and Journalism, and there are large number of failures every year in the subject of Modern Languages (EL). Principal explained the reason for the failures and the negative impact it has on admissions to the B A course. At the outset, Prof. Y.Ashok, Principal of the College, welcomed Col.(Retd) M. Vijay Rao, Hon. Director, BVC and all the other members of the Academic Council. He narrated the sequence of events that culminated in the award of autonomous status to the college in the month of May, 2015, and thanked the UGC and the University for conferring this distinction. He also informed the Council about the resolution of the Governing Body to implement Semester System from the academic year 2015-16 for instruction and to introduce Choice Based Credit System (CBCS) in the curriculum from the academic year 2016 – 17 based on the model suggested by UGC and the University.

I-3.0 The members of the Council discussed the items in the Agenda and **RESOLVED** as follows:

Item I-2.0(a): Admissions -2015-16: Noted. Suggested to include the information regarding the number of applications received versus the seats available in each of the programme to reflect the demand for admissions in the college.

<u>Item I-2.0(b):Students Results – 2014-15:</u> Noted with the observation that the results are excellent and much above the university average. The Council congratulated the faculties of the college for this achievement.

<u>Item I-2.0(c):Almanac 2015-16:</u> The almanac for the academic year 2015-16 is approved with a suggestion to explore the possibility of adjusting the teaching programme in five days of the week and keep the sixth day free for student's self-study, library work, project work, extra-curricular activities etc.

Item I-2.0(d): Ceiling on Strength: The College is advised to follow the same rules for the

ceiling strength and additional intake as approved by Osmania University for the academic year 2014-2015.

<u>Item I-2.0(e): BOS Constitution:</u> The Boards of Studies constituted by the Principal for various subjects by following the autonomy guidelines have been approved. The syllabi recommended by the BOS have been approved for semesters I and II only in all the subjects.

<u>Item I-2.0(f):Other Points</u>: The Council has recommended the implementation of the following measures under autonomy in the college:

(i) A comprehensive 'Vision Plan' for the next five years with targets, action plan and time-lines to be presented in the next Academic Council meeting.

(ii) A 'Standing Committee' of the Academic Council must be constituted by the Chairman to facilitate faster movement of academic decisions in the college. All the decisions of Standing Committee will be subject to the final approval of the Academic Council.

(iii) The rules for Admission, CBCS and Examinations must be finalized at the earliest for implementation of autonomy in the college.

(iv) Student representative(s) to be included in the Academic Council.

(v) The Internal Assessment (IA) of students should be a continuous process, and not based on one or two tests. The IA may include regularity in attendance, home assignments, slip-tests, seminar presentations, group discussions, mini-projects, examinations etc., A Formal Note be prepared for uniformity of its application.

(vi) A 'Grievance Redressal Cell' to be constituted as per UGC regulations, 2012.

(vii) The students should be assigned some non-confidential work as projects under 'Earn-While you learn' programme.

(viii) A faculty member may be appointed to liaise with UGC and other funding agencies.

(ix) The academic schedule of the degree programme should be structured in such a way that the last semester should focus on industry experience for the students, and allow working in incubation centre.

(x) The college should collaborate with industry and local chapters of prestigious national institutions like IIM(A) by inviting experts (to lecture) as adjunct faculty.

Hon.Director, Col. (Retd) M.Vijay Rao assured the Academic Council of the necessary support and guidance from the Management for all endeavours of the college.

The meeting ended with vote of thanks by Ms. Madhuri Mathur; Member-Secretary of the Academic Council.
