Exploratory Data Analysis Using R Programming

The Department of Commerce at Bhavan's Vivekananda College, Sainikpuri, organized an insightful guest lecture on Exploratory Data Analysis (EDA) using R, led by Dr. Goutham Goud, a statistician and PhD from Osmania University. The session, attended by second-year B.Com (Hons Business Analytics) students, provided a deep dive into the fundamentals of R programming and its application in data analysis. Dr. Goud introduced key statistical concepts and walked students through data transformation, cleaning, and visualization techniques. He explained essential EDA methods, including descriptive statistics (mean, median, variance, standard deviation), data visualization (histograms, box plots, scatter plots, correlation matrices), handling missing data (imputation, omission), and data transformation (normalization, scaling). A hands-on session in RStudio allowed students to practice importing datasets, performing statistical summaries, visualizing data, and identifying outliers. The lecture concluded with an interactive Q&A session, where students explored real-world applications of R in data analysis. Dr. Goud's clear explanations and engaging approach made the session both practical and enriching, helping students better understand EDA and its significance in data-driven decision-making.

Appa Rao, President, Indian Accounting Association, (IAA) Hyderabad branch. The Guest of Honour was Mr.P.R. Ramesh, Ex-Chairman, Deloitte, Hyderabad. The event began at 2:00 pm and was attended by Researchers, Academicians, PG Students and other delegates in blended mode. The main objective of the Seminar was to focus on the financial misconduct practiced by various entities and companies in India. The Seminar was also organised to create an awareness about of Financial Shenanigans amongst online and offline Participants. This great endeavour was initiated by the team IAA. Dr. D. Obul Reddy, Chairman, Indian Accounting Association, Hyderabad Chapter, CMA, Prof. G. Naresh Reddy, Secretary, IAA, Hyderabad Branch. Prof. Achalapathi (Retd), Prof. Krishna Kumar (retd), Prof. Patrick, Department of Commerce, Hyderabad were amongst the dignitaries present. To mark auspicious beginning of the seminar dignitaries were invited to proceed with the lighting of the lamp, which signified the illumination of knowledge which was accompanied by Bhavan's prayer with the help choir group. Mrs.L.V. Kamala Devi, Head Department of Commerce, BVC delivered a welcome address and introduced the theme of the seminar to the audience present. However, He focused on as to there should be selfcheck rather than a framework by regulation authorities to curb such acts in the society. Prof. Naresh Reddy, Secretary, IAA shared his views on the organising the National Seminars in various noted colleges that in twin cities as a part of the main theme framed by Indian Account Association which is to be held at International Conference, Kolkata, in collaboration with Indian Accounting Association and all the programmes are successful organised by the active participation by the professionals across the nation. Mr P R Ramesh made a remarkable insight in his speech by stating that in the field of accounting and auditing lay adequate sources as to be a check on the entities and the society which affects on a large scale. Sr.Prof. Appa Rao (Retd) addressing the audience expressed his views on the importance and timely selection of such topic to organise a National Seminar and he also suggested to organise to such seminars to bring researchable presentations by the scholars and academicians. It was a welcoming step felt by the audience present and acclaimed on his thought.









The Technical Session I,began at 2.45 pm addressed by the eminent Resource person as well as Guest of Honor for the day Mr. P. R. Ramesh, Former Chairman, Deloitte, who enlightened the participants by highlighting on the global frauds committed till date with various headlines quoted in news on day-to-day. Mr Ramesh has also listed the types of frauds such as management frauds, technical frauds, cybercrimes, etc, which is causing Billion Dollar loss to the Global Economy. He also added that the various regulatoryagencies have been introduced to detect as well to mitigate such frauds. He emphasized on the need for diligence by the corporate entities to curb such fallacies and lead to economic growth. The session provided a comprehensive view to be addressing the shenanigans from the internal management and a check by the external agencies monitoring would be minimised. Such remedial practices lead to the overall sound performance by the entities and a lightening hope for the future growth.

The Speaker of Session II of the seminar was Dr. Rachappa Shette, Associate Professor, IIM- Kozhikode, who delivered valuable insights on the effect of Financial Shenanigans on Financial statements and also its effect on qualitative disclosures. Dr. Rachappa has also highlighted various models to detect Financial Shenanigans along with insights on Researchable Ideas for Researchers. He attempted to disclose certain Financial Statements which are managerially designed to misrepresent the financial performance as true, in these lines he developed few models which are measures to resolve the issues concerned to financial shenanigans. The Models presented by him are as follows:

Model 1 covers Discretionary Accounts which deals with the variances between actual accrual and expected accruals.


Model II covers Real Measures which is shown through higher abnormal net cashflows.

Model III includes Digital Analysis, in which he explained Benford's Law, refer to occurrence of more zeros and less nines in case of profits and occurrence of less zeros and more nines in case of losses.

Model IV explains Discontinuity in Earnings Method, in which there should be significant difference between Profit After Tax covering numerical differences which are significant.

Model V focused on Manipulation Score (M-Score), where the link is established to test M-Score so as to arrive the cut-off point as -0.78.

Model VI emphasized on the Textual Analysis of quantitative Disclosures in Annual Report, where in Readability Analysis, other textual analysis to detect the Jog Index.
