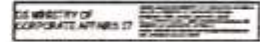

PESTICIDE FREE FARMING



The Entrepreneur Development Cell of Bhavan's Vivekananda College has come up with a new activity on 8th of November 2019 which is **PESTICIDE FREE FARMING**. The main objective of this initiative is to inculcate entrepreneurial skills through farming among the students. In addition to this, the program also aims to develop a pesticide-free farming business module. Another objective of this program is to grow, sell and make available organic potted plants for various programs conducted by different departments in the college and outside.

It started with an investment of 13,300 rupees sanctioned out of the seed money of ED Cell. Initially, the required materials were purchased. The next process was sowing different variety of seeds such as Palak, Tomato, Okra, Coriander, Mesta, Amaranth leaves. The entire activity is set up on the terrace of biochemistry block and also in the Poly house of the college. Students associated with this program have to water plants according to the schedule on a rotation basis. There are set of guidelines framed by the ED Cell for functioning of this activity. As part of this pesticide free farming, students agreed that any profit gained out of the plants sold will be invested back again for the expansion of the program. 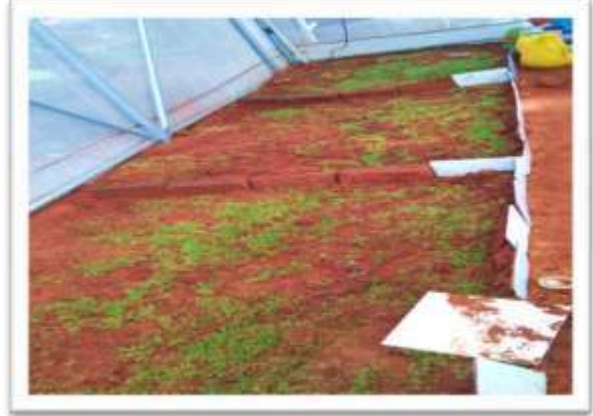
